### Music Performance License

You are eligible for additional Music Performance and Music Live Streaming Licenses from Global Music Rights (GMR) and AllTrack if you are a member of at least one of the following associations: NFDA, NFD&MA, OGR, SIFH, or an NFDA federated state association (choice or partnership).

U.S. Copyright Law requires a music performance license for all establishments that play copyrighted music. With NFDA, you can pay only \$199 to access music from Global Music Rights (GMR) and AllTrack and avoid penalties of up to \$30,000, more if the violation is deemed to be intentional and potentially even more in damages to the copyright holder. Don't take that risk. You'll have peace of mind through Dec. 31, 2026, in knowing you're not violating the law.

### Live Streaming License

While the music performance license covers performances, a different license is required for a funeral home to stream musical performances over the internet in conjunction with a funeral, memorial service, or ceremony. Unless it has a separate live streaming license, a funeral home that offers funeral live streaming services is violating copyright laws when they broadcast over the internet any funeral service that contains copyrighted music even if it has a performance license.

NFDA has finalized agreements with GMR and AllTrack to a live streaming license that enables you to legally live stream funeral services that include covered copyrighted music over the internet from their catalogs. With NFDA, you pay only \$45 per website for these licenses to avoid penalties of up to \$30,000. With these licenses you'll have peace of mind through Dec. 31, 2026 in knowing you're not violating the law.
